May kindly see the property statements online received from Smt. In this connection, it is submitted that as per statement of movable and immovable properties for the financial years 2018-19 & 2019-20 of the officer concerned, details of income, deduction, savings investment and expenditure made by her are given below.

(1) In the financial years 2018-20, Total income is Rs.47,61,482/- (total Gross salary are Rs.31,79,032/-, Bank interests of Rs.1,73,160/-, LIC money back policy of Rs.29,180/-, LLM arrear of Rs.8,22,029/-, D.A. Arrear of Rs.15,390/-, Pay commission Interim Relief of Rs.4,19,277/-, salary of E.L. of Rs.24,706/- and arrear of 1st ACP of Rs.98,708/-) and total deductions/ repayment/ savings/ investment (for both the financial years) against GIS, CPF, Income Tax, loans, Insurance policies, PPF and the balance of her savings bank account(s) is neither enhanced nor reduced for this financial year, total of which is Rs.29,20,323/-. Thus, a sum of Rs.18,41,159/- was therefore available with her to meet out the household expenditure of her family consisting three members in both the financial years.

It is pertinent to be mention here that her husband is Judicial Officer having total annual income of Rs.35,84,432/- for the financial years 2018-20.

In this connection, it is submitted that the officer has already submitted her property statement upto the financial years 2013-14 which had already been seen by Hon'ble Mr. Justice Shabihul Hasnain, the then Administrative Judge, Bulandshahar in the misc. file of the officer. And property statements of 2014-16 & 2016-18 has been processed on e-service ID nos.920 & 921 respectively.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit her property statement for the financial years 2018-19 & 2019-20 in its next financial year i.e., 2020-21 upto March 2021. She has submitted movable and immovable property statements for the financial years 2018-19 & 2019-20 vide online dated 18.01.2021. As such, there is no delay in submitting the same.

May, therefore, if approved, property statements for the financial years 2018-19 & 2019-20 of Smt. Nupur, Additional District & Sessions Judge (Fast Track Court), Banda be laid before Hon'ble Mr. Justice Rajesh Singh Chauhan, Administrative Judge, Banda Judgeship for His Lordship's kind perusal and orders?
