May kindly see the property statement submitted online dated 3.12.2021 received from Sri Bhupendra Rai, Law Officer, U.P.Power Corporation Ltd. Lucknow regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family for the financial years 2018-20 ( financial year 2018-19 & 2019-20) in the prescribed proforma to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial years years 2018-20 ( financial year 2018-19 & 2019-20) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below.

(1) In the financial years years 2018-20 ( financial year 2018-19 & 2019-20) total income from Salary & arrear is Rs.44,88,929 and total deductions/ repayment/ savings/ investment (for both the financial years) against GPF, GIS, Income Tax, PLIC, LIC, SIP and PPF and the balance of his savings bank account(s) is also enhanced for Rs.7,37,077/- this financial year from previous year's balance, total of which is Rs.28,16,617/-. Thus, a sum of Rs.16,72,312/- was therefore available with him to meet out the household expenditure of his family consisting of four and three members for the financial years 2018-19 & 2019-20 respectively.

It is pertinent to mention here that mother of the officer is pensioner her pension is Rs.13,500/- per month and wife of the officer earns Rs.140,000/- to 160,000/- yearly from Tuition.

In this connection, it is submitted that the officer has already submitted his property statements upto financial years 2016-18 which had already been seen by Hon'ble Mr. Justice V.K.Birla, Administrative Judge, Unnao Judgeship in the Misc. file of the officer.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement of the financial years 2018-20 ( financial year 2018-19 & 2019-20) in its next financial year i.e., 2020-21 upto March 2021. He has submitted the same vide his online letter dated 13.12.2020. As such, there is no delay in submitting the same from the part of the officer.

May, therefore, if approved, property statements of the financial years 2018-20 ( financial year 2018-19 & 2019-20) of Sri Bhupendra Rai, Law Officer, U.P.Power Corporation Ltd. Lucknow be laid before Hon'ble Mr. Justice Mahesh Chandra Tripathi, Administrative Judge, Lucknow Judgeship for His Lordship's kind perusal and orders?
