May kindly see the property statement online received from Sri. Surendra Mohan Sahay, Additional Civil Judge (POCSO), Aligarh regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family of the financial years 2014-16 (2014-15 & 2015-16) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per the statement of movable and immovable properties for the financial years 2014-16 (2014-15 & 2015-16) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below:

(1). In the financial year 2014-16 (2014-15 & 2015-16), Gross income from salary Rs. 25,30,664/- and total deductions/savings/ investment against GPF, GIS, Income Tax, PPF, LIC policy is Rs.8,63,976 . Thus a sum of Rs. 16,66,688/- was therefore available with him to meet out the household expenditure of his family consisting of four members in the financial year 2014-16 (2014-15 & 2015-16) and the balance of his savings account is also decreased for Rs.5,19,275 /- this financial year from previous year balance.

It is pertinent to mention here that Officer's wife (play school manager) having annual income Rs.3,00,000.

In this connection, it is submitted that the Officer has already submitted his property statement of the financial year 2012-14(2012-13 & 2013-14) offline seen by Hon'ble Mr. Justice S.K. Gupta, the then Administrative Judge, Meerut in the Misc. file of the officer.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial years 2014-16 (2014-15 & 2015-16) in its next financial year i.e., 2016-17 upto March 2017. He has submitted movable and immovable property statements of the financial year 2014-16 (2014-15 & 2015-16) vide online dated 09.12.2021. As such, there is delay in submitting the same. In this regard, officer stated that's details of movable and immovable property for the financial year 2014-16 (2014-15 & 2015-16) could not be sent by mistake in time. Therefore, the officer apologizes for the late submission of details.

May, therefore, if approved, property statements for the financial years 2014-16 (2014-15 & 2015-16) of Sri. Surendra Mohan Sahay, Additional Civil Judge (POCSO), Aligarh be laid before Hon'ble Mr. Justice Vivek Chaudhary, Administrative Judge, Aligarh for His Lordship's kind perusal and orders?
