May kindly see the property statement submitted online dated 02.01.2021 received from Sri Mahendra Singh Paswan, Civil Judge(Sr.Div.), Fatehpur regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family for the financial years 2016-18 [ financial year 2016-17(from 09.02.2017 to 31.3.2017) & 2017-18] in the prescribed proforma to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial years years 2016-18 [ financial year 2016-17(from 09.02.2017 to 31.3.2017) & 2017-18] of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below.

(1) In the financial years years 2016-18 [ financial year 2016-17(from 09.02.2017 to 31.3.2017) & 2017-18] total income from Salary & other Sources ( i.e. arrears and Bank interest) is Rs.9,64,126/- and total deductions/ repayment/ savings/ investment (for both the financial years) against NPS, GIS, Income Tax, LIC and PPF, and the balance of his savings bank account(s) is also enhanced for Rs.16,498/- this financial year from previous year's balance, total of which is Rs.226836/-. Thus, a sum of Rs.7,37,290/- was therefore available with him to meet out the household expenditure of his family consisting two members for both the financial years.

In this connection, it is submitted that the officer has already submitted his property statements at the time of entering into U.P. Judicial Service which has been seen by Hon'ble Mr. Justice R.R.Awasthi, the then Administrative Judge, Barabaanki Judgeship with the remark that the Judicial officer concerned shall furnish his movable and immovable property statements well within time in future in the misc. file of the officer.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement of the financial years 2016-18 [ financial year 2016-17(from 09.02.2017 to 31.3.2017) & 2017-18] in its next financial year i.e., 2018-19 upto March 2019 .As such, there is delay in submitting the same from the part of the officer and the officer has not mentioned any reason for delay.

May, therefore, if approved, property statements of the 2016-18 [ financial year 2016-17(from 09.02.2017 to 31.3.2017) & 2017-18] of Sri Mahendra Singh Paswan, Civil Judge(Sr.Div.), Fatehpur be laid before Hon'ble Mrs . Justice Manju Rani Chauhan, Administrative Judge, Fatehpur Judgeship for Her Lordship's kind perusal and orders?
