May kindly see the property statement online received from Sri. Surendra Mohan Sahay, Additional Civil Judge (POCSO), Aligarh regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family of the financial years 2018-20 (2018-19 & 2019-20) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per the statement of movable and immovable properties for the financial years 2018-20 (2018-19 & 2019-20) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below:

(1) In the financial years 2018-20 (2018-19 & 2019-20), Gross income from salary Rs. 49,61,075/- and total deductions/savings/ investment against GPF, GIS, Income Tax, PPF, LIC policy, Mutual fund's, Repayment of car loan & Down-payment and the balance of his savings bank account(s) is also increased by Rs.14,04,926/- in this financial year from previous year's balance, total of which is Rs.40,27,797/-. Thus, a sum of Rs.9,33,278/- was therefore available with him to meet out the household expenditure of his family consisting four member in the both of the financial year.

It is pertinent to mention here that Officer's wife (play school manager) having annual income Rs.3,80,000.

In this connection, it is submitted that the Officer has already submitted his property statement of the financial year 2016-18 (2016-17 & 2017-18) online against case id-P00009662020 and same has been moved before Hon'ble Mr. Justice Vivek Chaudhary, Administrative Judge, Aligarh for His Lordship's kind perusal and orders.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial years 2018-20 (2018-19 & 2019-20) in its next financial year i.e., 2020-21 upto March 2021. He has submitted movable and immovable property statements of the financial year 2018-20 (2018-19 & 2019-20) vide online dated 09.12.2021. As such, there is delay in submitting the same. In this regard, officer stated that's details of movable and immovable property for the financial year 2018-20 (2018-19 & 2019-20) could not be sent by inadvertently in time. Therefore, officer requested for apologize for the late submission of details.

May, therefore, if approved, property statements for the financial years 2018-20 (2018-19 & 2019-20) of Sri. Surendra Mohan Sahay, Additional Civil Judge (POCSO), Aligarh be laid before Hon'ble Mr. Justice Vivek Chaudhary, Administrative Judge, Aligarh for His Lordship's kind perusal and orders?
