

## **Joint Registrar(J)(Budget)**

May kindly see the property statement online received from Smt. Anuradha Pundir, Additional Principal Judge, Family Court, Aligarh regarding submission of statement of movable and immovable properties acquired/held by her or any member of her family for the financial years 2018-19 & 2019-20 in the prescribed proforma respectively to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial years 2018-19 & 2019-20 of the officer concerned, details of income, deduction, savings investment and expenditure made by her are given below.

(1) In the financial years 2018-19 & 2019-20, Total income is Rs.32,76,195/- (Gross annual salary with arrears are Rs.31,48,525/-, amount received from redemption of some units of HDFC Top of Rs.1,00,000/- and amount received on maturity of NSC of Rs.27,670/-) and total deductions/ repayment/ savings/ investment (for both the financial years) against NPS, GIS, Income Tax, PPF a/c, Mutual fund and Insurance policies are Rs.14,39,249/-. Thus, a sum of Rs.18,36,946/- was therefore available with her to meet out the household expenditure of her family consisting four members in both the financial years. And the balance of her SB a/cs is also reduced for Rs.29,365/- in this financial year from previous year's balance.

It is pertinent to mention here that her husband is also a judicial officer having annual income of Rs.19,82,456/- & Rs.17,14,038/- in the financial years 2018-19 & 2019-20 respectively.

In this connection, it is submitted that the officer has already submitted her property statement upto the financial years 2017-18 which has already been seen by Hon'ble Mr. Justice Pankaj Naqvi, the then Administrative Judge, Pilibhit in the misc file of the officer.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit her property statement for the financial years 2018-19 & 2019-20 in its next financial year i.e., 2020-21 upto March 2021. She has submitted movable and immovable property statements for the financial years 2018-19 & 2019-20 vide online dated 01.01.2021. As such, there is no delay in submitting the same from the part of the officer.

May, therefore, if approved, property statements for the financial year 2018-19 & 2019-20 of Smt. Anuradha Pundir, Additional Principal Judge, Family Court, Aligarh be laid before Hon'ble Mr. Justice Ashwani Kumar Mishra, Administrative Judge, Aligarh Judgeship for His Lordship's kind perusal and orders?
