

## **Registrar(Judicial)(Budget)**

May kindly see the online reply dated 09.01.2023 received from Sri Arun Kumar Rai, the then Additional District and Sessions Judge, Hamirpur now posted as Additional Principal Judge, Family Court, Bahraich, in compliance of order of Hon'ble Mr. Justice Manish Mathur, Administrative Judge, Hamirpur in the matter of property statement for the financial years 2015-17 (2015-16 & 2016-17), communicated to the officer.

In this connection, it is submitted that the officer had submitted his movable & immovable property statements for the financial years 2015-17, which was put up before Hon'ble the Administrative Judge, Mathura through detailed office note dated 14.07.2022, on which His Lordship has been pleased to pass the following order dated 10.11.2022:

**“The officer while submitting the property statement has not disclosed the sources of the amount invested in the respective years and also of balance amounts lying in the bank accounts under the relevant columns. He shall resubmit the property statement strictly adhering to the norms.”**

The order of the Court had been communicated to the officer concerned on 17.11.2022.

In reply of the Hon'ble Court's objection, the officer concerned has uploading the updated proforma on 09.01.2023 and stated that *“Updated accordingly as per direction of the Hon'ble Court..”*

In this connection, it is submitted that as per statements of movable and immovable properties for the financial years 2015-17 (2015-16 & 2016-17) of the officer, concerned, details of income, deductions, savings, investment and expenditure made by him are given below.

**In the financial year 2015-17 (2015-16 & 2016-17)**, his Total income from salary and other sources is Rs. 27,68,917/- (Salary Rs. 26,34,286/-, Interest Rs. 52,681/-, NSC matured 41,297 and FDR matured 40,653) and total deductions/savings/investments against GIS, CPF, Income Tax, PPF, Insurances, and SIP (Mutual Fund) is Rs. 14,92,213/- (including enhancement of Rs. 7,61,380/- in his S.B. A/cs against the balance of the previous year). Thus a sum of Rs. 12,76,704/- was therefore available with him to meet out the household expenditure of his family consisting of four members in both the financial years.

In this connection, it is submitted that the officer has already submitted his property statements online for the financial year 2013-15 (2013-14 & 2014-15) which is also approved online by Hon'ble Mr. Justice Alok Mathur, Administrative Judge, Bahraich, for kind perusal and order on e-service Id no. 1899.

It is further submitted that as per policy/Court's Circular letter, the officer has to submit his property statements for the financial year 2015-17 (2015-16 & 2016-17) in its next financial year i.e., 2017-18 upto 31st March 2018. He has submitted movable and immovable property statements for the financial years 2015-17 (2015-16 & 2016-17) firstly vide his application dated 24.12.2020. As such, there is delay in submitting the same from the part of the officer for which he has mentioned in remark column that *“unfortunately by mistake, due to access work load, sickness of old age parents & child and non availability of some data submission of property statement is delayed. He begs his pardon.”*

May, therefore, if approved, property statement of the financial years 2015-17 (2015-16 & 2016-17) alongwith the updated proforma of the same, as desired by the Court in the matter, furnished by Sri Arun Kumar Rai, Additional Principal Judge, Family Court, Bahraich be laid before Hon'ble Mr. Justice Raj Beer Singh, Administrative Judge, Bahraich Judgeship for His Lordship's kind perusal and orders?
