May kindly see the property statement submitted online received from Sri Pramod Kumar Srivastava-II, Principal Secretary (Law) & L.R., Govt. of U.P., Lucknow regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family of the financial years 2018-19 & 2019-20 in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial years 2018-19 & 2019-20 of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below:-

(1) In the financial years 2018-19 & 2019-20, Total income is Rs.64,16,893/- [Gross Income from salary (including SB interest & LIC maturity) is Rs.53,49,244/- and matured amount of PPF of RS.10,67,649/-] and total deductions/ repayment/ savings/ investment (of both the financial years) against GIS, GPF, Income Tax, Insurance policies, Home loan, SIP, PPF a/c and the balance of his savings bank account(s) is enhanced for Rs.9,95,591/- this financial year from previous year's balance, total of which is Rs.50,27,414/-. Thus, a sum of Rs.13,89,479/- was therefore available with him to meet out the household expenditure of his family consisting four members in both the financial years 2018-19 & 2019-20. It is also to mention here that his wife's vocational income of Rs.5,07,900/- and his son's income of Rs.11,80,000/- from private job.

In this connection it is submitted that officer has already submitted his property statement upto the financial year 2013-14 which had already been seen by Hon'ble Mr. Justice Ritu Raj Awasthi, the then Administrative Judge, Unnao and statement of the financial years 2014-15 to 2017-18, which has laid before Hon'ble Mr. Justice Surya Prakash Kesarwani, Administrative Judge, Lucknow for kind perusal & order, in the misc. file of the officer. It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial year 2018-19 & 2019-20 in its next financial year i.e., 2020-21 upto March 2021. He has submitted movable and immovable property statements of the financial year 2018-19 & 2019-20 firstly online dated 03.01.2021. As such, there is no delay in submitting the same from the part of the officer.

May, therefore, if approved, property statements for the financial years 2018-19 & 2019-20 of Sri Pramod Kumar Srivastava-II, Principal Secretary (Law) & L.R., Govt. of U.P., Lucknow be laid before Hon'ble Mr. Justice Surya Prakash Kesarwani, Administrative Judge, Lucknow Judgeship for His Lordship's kind perusal and orders?
