May kindly see the property statement submitted online received from Sri Devendra Singh-II, Presiding Officer, Motor Accident Claims Tribunal, Etawah regarding submission of statements of movable and immovable properties acquired/held by him or any member of his family for the financial year 2017-19 (2017-18 & 2018-19) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statements of movable and immovable properties for the financial years 2017-19 (2017-18 & 2018-19) of the officer, concerned, details of income, deductions, savings, investment and expenditure made by him are given below.

In the financial year 2017-19 (2017-18 & 2018-19), his Total income from salary and other sources is Rs. 40,37,529/- (Gross salary including allowances Rs. 39,87,319/- and Agriculture income Rs. 50,210/-) and total deductions/savings/investments against GIS, NPS, Income Tax, Insurances (LIC & SBI Life policy), PPF and SIP is Rs. 20,86,058/- (including enhancement of Rs. 2,54,888/- in his S.B. A/cs against the balance of the previous year). Thus a sum of Rs. 19,51,471/- was therefore available with him to meet out the household expenditure of his family consisting four members in both the financial years.

It is pertinent to mention here that his wife is an advocate and her annual income is Rs. 4,90,000/- approximately.

In this connection, it is submitted that the officer has already submitted his property statements offline for the financial year 2016-17 which has already been seen offline by Hon'ble Mr. Justice R. R Awasthi, the then Administrative Judge, Shahjahanpur Judgeship with the direction that the Judicial officer concerned shall furnish his movable and immovable property statements well within time.

It is further submitted that as per policy/Court's Circular letter, the officer has to submit his property statements for the financial year 2017-19 (2017-18 & 2018-19) in its next financial year i.e., 2019-20 upto 31st March 2020. He has submitted movable and immovable property statements for the financial years 2017-19 (2017-18 & 2018-19) firstly vide his application dated 08.01.2021. As such, there is delay in submitting the same from the part of the officer and the officer has not submitted any reason for the same.

May, therefore, if approved, property statements for the financial years 2017-19 (2017-18 & 2018-19) of Sri Devendra Singh-II Presiding Officer, Motor Accident Claims Tribunal, Etawah, be laid before Hon'ble Mr. Justice Karunesh Singh Pawar, Administrative Judge, Etawah Judgeship for His Lordship's kind perusal and orders?
