May kindly see the property statement submitted online dated 05.01.2021 received from Sri Shailesh Kumar Tiwari, the then Additional District & Sessions Judge, Amroha presently posted as Presiding Officer, Motor Accident Claim Tribunal, Bhadohi at Gyanpur regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family of the financial years 2018-19 & 2019-20 in the prescribed proforma respectively to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial years 2018-19 & 2019-20 of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below.

(1) In the financial years 2018-19 & 2019-20, Total income is Rs.57,65,379/- (Gross income from pay, arrears, T.A., allowances & interim relief arrears of Rs.53,67,486/-, SB interests of Rs.13,484/-, House rent of Rs. 3,02,400/- and mod interest of RS.82,009/-) and total deductions/ repayment/ savings/ investment (for both the financial years) against GIS, CPF, Income Tax, Home loan, SIP, LIC, PPF and the balance of his savings bank account(s) is enhanced for Rs.1,01,862/- this financial year from previous year's balance, total of which is Rs.27,30,344/-. Thus, a sum of Rs.30,35,035/- was therefore available with him to meet out the household expenditure of his family consisting four members in both the financial years.

In this connection, it is submitted that the officer has already submitted his property statement upto the financial years 2017-18 which had already been seen by Hon'ble Mr. Justice Pritinker Diwaker, the then Administrative Judge, Amroha in the misc. file of the officer.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial years 2018-19 & 2019-20 in its next financial year i.e., 2020-21 upto March 2021. He has submitted movable and immovable property statements of the financial years 2018-19 & 2019-20 vide online dated 05.01.2021. As such, there is no delay in submitting the same from the part of the officer.

May, therefore, if approved, property statements for the financial years 2018-19 & 2019-20 of Sri Shailesh Kumar Tiwari, Presiding Officer, Motor Accident Claim Tribunal, Bhadohi at Gyanpur be laid before Hon'ble Mr. Justice Shamim Ahmed, Administrative Judge, Bhadohi at Gyanpur Judgeship for His Lordship's kind perusal and orders?
