May kindly see the property statement submitted online received from Sushri Nidhi Yadav, Civil Judge (Senior Division), Kunda, Pratapgarh regarding submission of statement of movable and immovable properties acquired/held by her or any member of her family for the financial years 2017-2019 (2017-18 & 2018-19) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statements of movable and immovable properties for the financial years 2017-2019 (2017-18 & 2018-19) of the officer, concerned, details of income, deductions, savings, investment and expenditure made by her are given below.

In the financial years 2017-2019 (2017-18 & 2018-19), her Total income from salary is Rs. 19,05,211/and total deductions/savings/investments against GIS, NPS, Income Tax, PPF and LIC is Rs. 8,41,163/-(including enhancement of Rs. 3,44,144/- in her S.B. A/cs against the balance of the previous year). Thus, a sum of Rs. 10,64,048/- was therefore available with her to meet out the household expenditure of her family consisting of herself only.

In this connection, it is submitted that the officer has already submitted his property statements online at the time of joining which is also processed online and laid before Hon'ble Mr. Justice Rahul Chauturvedi, Administrative Judge, Pratapgarh Judgeship for kind perusal and order on e-service Id no. 1710.

It is further submitted that as per policy/Court's Circular letter, the officer has to submit her property statements for the financial years 2017-2019 (2017-18 & 2018-19) in its next financial year i.e., 2019-20 upto March 2020. She has submitted movable and immovable property statements for the financial years 2017-2019 (2017-18 & 2018-19) on 06.01.2021. As such, there is no delay in submitting the same from the part of the officer, for which she has submitted that property statement was earlier submitted two times but due to some objections, it is again being submitted after removal of objections as required and requested that the delay caused may kindly be condoned.
