May kindly see the online property statements received from Sri Sanjay Kumar Singh-III, Additional District and Sessions Judge, Deoria, regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family for the financial year 2017-19 (2017-18 & 2018-19) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statements of movable and immovable properties for the financial years 2017-19 (2017-18 & 2018-19) of the officer concerned, details of income, deductions, savings, investment and expenditure made by him are given below.

In the financial year 2017-19 (2017-18 & 2018-19), his total income from salary, arrears and allowances is Rs. 28,72,178/- and total deductions/savings/investments against, NPS, GIS, Income Tax, PPF, Insurances (LIC, SBI Life- Smart Scholar policy and PLI Policy ), SIPs, and S.B.I-FD is Rs. 16,39,842 (including enhancement of Rs. 36,366/- in his S.B. A/cs against the balance of the previous year). Thus a sum of Rs. 12,32,336/- was therefore available with him to meet out the household expenditure of his family consisting of four members in both the financial years. It is pertinent to mention here that his wife is working as clerk at the office of B.D.O Sohanv, Ballia U.P.

In this connection, it is submitted that the officer has already submitted his property statements online for the financial year 2015-17 (2015-16 & 2016-17) which has also been processed online against case Id P00000352021 before Hon'ble Mr. Justice Rajeev Singh, Administrative Judge, Deoria for His Lordship's kind perusal and orders.

It is further submitted that as per policy/Court's Circular letter, the officer has to submit his property statements for the financial year 2017-19 (2017-18 & 2018-19) in its next financial year i.e., 2019-20 upto March 2020. He has submitted movable and immovable property statements for the financial years 2017-19 (2017-18 & 2018-19) vide online application dated 06.01.2021. As such, there is delay in submitting the same from the part of the officer, for which he has stated 'that property statement of his wife was not available to him earlier, so the property statement relating to year 2017-19 was not submitted by him within time, for which he is extremely sorry and begs pardon', as mentioned in his attachment letter.

May, therefore, if approved, property statements for the financial years 2017-19 (2017-18 & 2018-19) of Sri Sanjay Kumar Singh-III, Additional District and Sessions Judge, Deoria, be laid before Hon'ble Mr. Justice Rajeev Singh, Administrative Judge, Deoria for His Lordship's kind perusal and order?
