May kindly see the property statement submitted online received from Smt. Aparna Pandey, the then Secretary, Human Rights Commission, Dehradun presently posted as Additional District & Sessions Judge, Saharanpur regarding submission of statement of movable and immovable properties acquired/held by her or any member of her family for the financial years 2018-19 & 2019-20 in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial years 2018-19 & 2019-20 of the officer concerned, details of income, deduction, savings investment and expenditure made by her are given below.

(1) In the financial years 2018-19 & 2019-20, Total income is Rs.49,54,099/- (Gross income from salary & arrears are Rs.44,55,874/-, received from maturity of Bajaj allianz policy of Rs.4,19,163/-, received as money back from LIC policy of Rs.47,022/- and received as interest from saving bank account of Rs.32,040/-) and total deductions/ repayment/ savings/ investments (for both the financial years) against GIS, CPF, Income Tax, PPF, Personal loan, Mediclaim policy, RD and the balance of her savings bank account(s) is enhanced for Rs.4,82,474/- this financial year from previous year's balance, total of which is Rs.26,97,939/-. Thus, a sum of Rs.22,56,160/- was therefore available with her to meet out the household expenditure of her family consisting four members in both the financial years.

It is pertinent to mention here that her husband is I.A.S. Officer having annual income of Rs.31 lacs and Rs.32 lacs in the financial years 2018-19 & 2019-20 respectively.

In this connection, it is submitted that officer has already submitted her property statement upto the financial years 2017-18 which had already been seen by Hon'ble the Chief Justice in the misc. file of the officer.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit her property statements of the financial years 2018-19 & 2019-20 in its next financial year i.e., 2020-21 upto March 2021. She has submitted movable and immovable property statements of the financial years 2018-19 & 2019-20 vide online dated 27.02.2021. As such, there is no delay in submitting the same.

May, therefore, if approved, property statements of the financial year 2018-19 & 2019-20 of Smt. Aparna Pandey, Additional District & Sessions Judge, Saharanpur be laid before Hon'ble Mr. Justice Neeraj Tiwari, Administrative Judge, Saharanpur Judgeship for His Lordship's kind perusal and orders?
