May kindly see the property statement submitted online received from Sri Vidya Bhushan Pandey, presently posted as Additional District and Sessions Judge (F.T.C), Gonda regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family for the financial year 2013-15 (2013-14 & 2014-15) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statements of movable and immovable properties for the financial years 2013-15 (2013-14 & 2014-15) of the officer, concerned, details of income, deductions, savings, investment and expenditure made by him are given below.

In the financial year 2013-15 (2013-14 & 2014-15), his Total income from salary is Rs. 17,59,229/-(Annual income from salary and arrears is Rs. 16,77,829, R.D maturity Rs. 74,000 and Rs. 7,400/-approx interest on savings) and total deductions/savings/investments against CPF, GIS, Income Tax, PPF, Insurances (LIC) Post Office R.D., Home Loan and Car Loan is Rs. 9,67,933/- (including enhancement of Rs. 39,438/- in his S.B. A/cs against the balance of the previous year). Thus a sum of Rs. 7,91,296/- was therefore available with him to meet out the household expenditure of his family consisting of two members in both the financial years.

It is pertinent to mention here that his wife was working as software engineer in wipro Services Pvt. Ltd. at the time of marriage (after marriage she left the job)

In this connection, it is submitted that the officer has already submitted his property statements offline for the financial year 2012-13 and seen by Hon'ble Mr. Justice Ravindra Singh, the then Administrative Judge, Saharanpur.

It is further submitted that as per policy/Court's Circular letter, the officer has to submit his property statements for the financial year 2013-15 (2013-14 & 2014-15) in its next financial year i.e., 2015-16 upto 31st March 2016. He has submitted movable and immovable property statements for the financial years 2013-15 (2013-14 & 2014-15) firstly vide his application dated 10.03.2021. As such, there is delay in submitting the same from the part of the officer and he has submitted that due to his transfer from Saharanpur to Allahabad and due to work load, he could not submit the statement in time. His sincere apologies are prayed to the Hon'ble court for not submitting the same in time . In future, He will not be failing in his duty to submit the statements in time.

May, therefore, if approved, property statements for the financial years 2013-15 (2013-14 & 2014-15) of Sri Vidya Bhushan Pandey, presently posted as Additional District and Sessions Judge (F.T.C), Gonda, be laid before Hon'ble Mr. Justice Vivek Chaudhary, Administrative Judge, Gonda for His Lordship's kind perusal and orders?
