May kindly see the property statement submitted online received from Sri Bhoo Dev Gautam, Presiding Officer, Motor Accident Claims Tribunal, Jaunpur regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family for the financial year 2018-20 (2018-19 & 2019-20) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statements of movable and immovable properties for the financial years 2018-20 (2018-19 & 2019-20) of the officer, concerned, details of income, deductions, savings, investment and expenditure made by him are given below.

In the financial year 2018-20 (2018-19 & 2019-20), his Total income from salary and other sources (Gross Salary Rs. 50,03,794/-, Bank interest Rs.8,76,452 and income from Agriculture Rs.56,900/-) is Rs.59,37,146/- and total deductions/savings/investments against GPS, GIS, Income Tax, PPF, Insurances and FDR is Rs.53,79,042/-. Thus a sum of Rs.5,58,104/- was therefore available with him to meet out the household expenditure of his family consisting four members in both the financial years. The balance of his savings bank account(s) is also reduced for Rs.9,35,462/- this financial year from previous year's balance.

It is pertinent to mention here that his wife Mrs. Reeta Kaushik is Principal Judge, Family Court, Faizabad, in Pay Scale Rs. 70,290/

In this connection, it is submitted that the officer has already submitted his property statements online upto the financial year 2017-18 which has already been processed offline in the MISC. file of the officer before Hon'ble Mr. Justice Rajiv Joshi Administrative Judge, Jaunpur.

It is further submitted that as per policy/Court's Circular letter, the officer has to submit his property statements for the financial year 2018-20 (2018-19 & 2019-20) in its next financial year i.e., 2020-21 upto March 2021. He has submitted movable and immovable property statements for the financial years 2018-20 (2018-19 & 2019-20) firstly vide his application dated 27.01.2021. As such, there is some delay in submitting the same from the part of the officer and officer has not mentioned the reason for delay.

May, therefore, if approved, property statements for the financial years 2018-20 (2018-19 & 2019-20) of Sri Bhoo Dev Gautam, Presiding Officer, Motor Accident Claims Tribunal, Jaunpur, be laid before Hon'ble Mr. Justice Mayank Kumar Jain, Administrative Judge, Jaunpur for His Lordship's kind perusal and orders?
