May kindly see the property statements online received from Sri Anil Kumar Shukla,, Special Judge (SC/ST Act, Pev. Of Atroci Act), Barabanki regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family for the financial years 2016-18(2016-17 & 2017-18) in the prescribed proforma respectively to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial years 2016-18(2016-17 & 2017-18) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below.

(1) In the financial years 2016-18(2016-17 & 2017-18), Total income from Salary and other Sources(arrear & allowances) is Rs.30,79,106 and total deductions/ repayment/ savings/ investment against GPF, GIS, IT, LIC, PPF, car loans and the balance of his savings bank account(s) is also enhanced for Rs.8,68,214/- this financial year from previous year's balance is Rs.23,28,555/- . Thus, a sum of Rs.7,50,551/- was therefore available with him to meet out the household expenditure of his family consisting four members for both the financial years.

In this connection, it is submitted that the officer has already submitted his property statement upto the financial year 2015-16, which has already been seen by Hon'ble Mr. Justice S.N.Shukla, the then Administrative Judge, Lucknow for kind perusal and orders on the detailed office note, in the misc. file of the officer.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial years 2016-18(2016-17 & 2017-18) in its next financial year i.e., 2018-19 upto March 2019. He has submitted movable and immovable property statements of the financial years 2016-18 vide online dated 10.03.2021. As such, there is delay in submitting the same from the part of the officer for which he has stated that due to transfer and mistake he could not submit the same in due time and regretted.

May, therefore, if approved, property statements for the financial years 2016-18(2016-17 & 2017-18) of Sri Anil Kumar Shukla,, Special Judge (SC/ST Act, Pev. Of Atroci Act), Barabanki be laid before Hon'ble Mr. Justice Vivek Varma, Administrative Judge, Barabanki Judgeship for His Lordship's kind perusal and orders?
