May kindly see the property statement submitted online received from Sri Satya Prakash, Presiding Officer, Motor Accident Claims Tribunal, Mirzapur regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family for the financial year 2018-20 (2018-19 & 2019-20) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statements of movable and immovable properties for the financial years 2018-20 (2018-19 & 2019-20) of the officer, concerned, details of income, deductions, savings, investment and expenditure made by him are given below.

In the financial year 2018-20 (2018-19 & 2019-20), his total income from salary and other sources is Rs.64,88,661/- (Salary Rs.57,98,213/-, Rs.5,50,000/- from rental income and Rs.1,40,448/- from Bank interest) and total deductions/savings/investments against GPF, GIS, Income Tax, PPF, repayment of car loan, Insurances and the balance of his Saving bank A/c(s) is enhanced for Rs.79,344/- this financial year from previous year's balance, total of which is Rs.31,45,236/-. Thus a sum of Rs.33,43,425/- was therefore available with him to meet out the household expenditure of his family consisting four members in both the financial years.

It is pertinent to mention here that the wife of the officer earned from Computer Training & Job work Rs. 2.75 Lacs and Rs. 3 lacs Approx. in respectively financial years.

In this connection, it is submitted that the officer has already submitted his property statements offline upto the financial year 2017-18 which had already been processed offline before Hon'ble Mr. Justice Vivek Kumar Singh, Administrative Judge, Budaun in the misc. file of the officer.

It is further submitted that as per policy/Court's Circular letter, the officer has to submit his property statements for the financial year 2018-20 (2018-19 & 2019-20) in its next financial year i.e., 2020-21 upto March 2021. He has submitted movable and immovable property statements for the financial years 2018-20 (2018-19 & 2019-20) vide his application dated 04.02.2021. As such, there is no delay in submitting the same from the part of the officer.

May, therefore, if approved, property statements for the financial years 2018-20 (2018-19 & 2019-20) of Sri Satya Prakash, Presiding Officer, Motor Accident Claims Tribunal, Mirzapur, be laid before Hon'ble Mr. Justice Sanjay Kumar Pachori, Administrative Judge, Mirzapur for His Lordship's kind perusal and orders?
