May kindly see the property statement submitted online received from Sri Vidya Bhushan Pandey, presently posted as Additional District and Sessions Judge (F.T.C), Gonda regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family for the financial year 2015-17 (2015-16 & 2016-17) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statements of movable and immovable properties for the financial years 2015-17 (2015-16 & 2016-17) of the officer, concerned, details of income, deductions, savings, investment and expenditure made by him are given below.

In the financial year 2015-17 (2015-16 & 2016-17), his Total income from salary is Rs. 19,57,842/- (Annual income from salary and arrears is Rs. 19,34,174/- (Received pay arrears of E.L. Rs. 21,132/- and E.L. Encashment of Rs. 65,309/- & salary increased due to promotion in Senior Div. Cadre on 01.07.2016 and received payment of Rs. 49,111/- of E.L. period of 22 days of august 2015 in this financial year) R.D maturity Rs. 74,000 and Rs. 7,400/- approx interest on savings) and total deductions/savings/investments against CPF, GIS, Income Tax, PPF, Insurances (LIC and PNB Metlife child plan), R.D, Home Loan and Car Loan is Rs. 17,52,370/- (including enhancement of Rs. 2,48,811/- in his S.B. A/cs against the balance of the previous year). Thus a sum of Rs. 2,05,472/- was therefore available with him to meet out the household expenditure of his family consisting of three members in both the financial years.

In this connection, it is submitted that the officer has already submitted his property statements online for the financial years 2013-15 (2013-14 & 2014-15) which is also processed online and laid before Hon'ble Mr. Justice Vivek Chaudhary, Administrative Judge, Gonda for kind perusal and order on e-service Id no. 1985.

It is further submitted that as per policy/Court's Circular letter, the officer has to submit his property statements for the financial year 2015-17 (2015-16 & 2016-17) in its next financial year i.e., 2017-18 upto 31st March 2018. He has submitted movable and immovable property statements for the financial years 2015-17 (2015-16 & 2016-17) firstly vide his application dated 10.03.2021. As such, there is delay in submitting the same from the part of the officer and he has stated that due to his mid term transfer from Allahabad to Amroha (on promotion in Sr. Div Cadre) and due to heavy work load, he could not submit the statement in time. His sincere apologies are prayed to the Hon'ble Court for not submitting the same in time. In future, he will not be failing in his duty to submit the statements in time.

May, therefore, if approved, property statements for the financial years 2015-17 (2015-16 & 2016-17) of Sri Vidya Bhushan Pandey, presently posted as Additional District and Sessions Judge (F.T.C), Gonda, be laid before Hon'ble Mr. Justice Vivek Chaudhary, Administrative Judge, Gonda for His Lordship's kind perusal and orders?
