May kindly see the property statement submitted online received from Sri Vidya Bhushan Pandey, presently posted as Additional District and Sessions Judge , Rae bareli regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family for the financial year 2017-19 (2017-18 & 2018-19) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statements of movable and immovable properties for the financial years 2017-19 (2017-18 & 2018-19) of the officer, concerned, details of income, deductions, savings, investment and expenditure made by him are given below.

In the financial year 2017-19 (2017-18 & 2018-19), his Total income from salary is Rs. 47,53,475/- (Annual income from salary and arrears is Rs. 35,02,266/- interest on savings Rs. 25,326/-, NSC Maturity Rs. 3,80,88/-, maturity on RD Rs. 1,48,906/-, EL pay arrears Rs. 25,314/-, I.R arrears of commission Rs. 296,496/-. LLM three advance increment arrear Rs, 717049/-) and total deductions/savings/investments against CPF, GIS, Income Tax, PPF, Insurances (LIC and PNB Metlife child plan), SIP, Home Loan and NSC is Rs. 21,90,467/- Thus a sum of Rs. 25,63,008,- was therefore available with him to meet out the household expenditure of his family consisting of three members in both the financial years. And the balance of her savings bank account(s) is also reduced for Rs. 1,50,285/- this financial year from previous year's balance.

In this connection, it is submitted that the officer has already submitted his property statements online for the financial years 2015-17 (2015-16 & 2014-15) which has already been Seen by Hon'ble Mr. Justice Vivek Chaudhary, Administrative Judge, Gonda on e-service Id no. 2007.

It is further submitted that as per policy/Court's Circular letter, the officer has to submit his property statements for the financial year 2017-19 (2017-18 & 2018-19) in its next financial year i.e., 2019-20 upto 31st March 2020. He has submitted movable and immovable property statements for the financial years 2017-19 (2017-18 & 2018-19) firstly vide his application dated 10.03.2021. As such, there is delay in submitting the same from the part of the officer for which he has submitted that due to wide spread of Covid 19 Pandemic, he could not submit the statement in time. He has sincerely apologised for the same and has stated that he will not be failing in his duties to submit the statements in time, in future.

May, therefore, if approved, property statements for the financial years 2017-19 (2017-18 & 2018-19) of Sri Vidya Bhushan Pandey, presently posted as Additional District and Sessions Judge, Rae bareli be laid before Hon'ble Mr. Justice Siddharth, Administrative Judge, Raebareli for His Lordship's kind perusal and orders?
