- 7. He has a PPF account in Post office of Allahabad High Court having account number 4137378889. Balance is Rs. 3,05,733/-
- 8. He has purchased a NSC from Post office of Allahabad High Court on 20.06.2018, worth Rs. 2,00,000/-
- 9. He has a R.D. in Post office of Allahabad High Court which was opened on 28.11.2016 (Balance is Rs. 76,000/-).
- 10. He has a LIC policy (No. 316268697) having premium of Rs. 21,948/- (Half yearly), purchased on 28.05.2017.
- 11. He has also owned a plot of 0.022 acres, (estimated value Rs. 27,00,000/-) which he has purchased before joining in the service.

It is further submitted that as per policy/ Hon'ble Court's Circular letter, the officer has to submit his property statement at the time of entering into judicial service just after joining into judicial service. He has submitted movable and immovable property statement at the time of joining into U.P. Judicial Service through his online letter dated 27.11.2021 As such, there is delay in submitting the aforesaid property statements from the part of the officer for which no reason was submitted in his online letter dated 27.11.2021.

May, therefore, if approved, property statement at the time of entering i.e. of joining into U.P. Judicial Service of Sri Abhay Kumar, Civil Judge (Junior Division), Pratapgarh be laid before Hon'ble Mr. Justice Rahul Chaturvedi, Administrative Judge, Pratapgarh Judgeship for His Lordship's kind perusal and orders?
