May kindly see the property statement online received from Sri Vishwanath, the then Additional Principal Judge, Family Court, Sitapur presently Additional District & Sessions Judge, Ambedkar Nagar regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family of the financial years 2018-2020 (2018-2019 & 2019-2020) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial years 2018-2020 (2018-2019 & 2019-2020) of the officer concerned, details of income, deduction, savings, investment and expenditure made by him are given below:

(1) In the financial years 2018-2020, total income from Salary and other sources is Rs. 54,68,664/- (Income from salary - 42,74,862/-, 30% interim Relief Rs.4,61,802/- and from PLI Rs.7,32,000/-) and total deduction/ repayment/ savings/ investment/ against GPF, GIS, PPF, PLI, LIC, SIP, Income Tax and repayment of Home loan are Rs.31,68,484/- (including enhancement of Rs. 715378/- in his S.B. A/cs against the balance of the previous year). Thus, a sum of Rs.23,00,180/- was available with him to meet out the household expenditure of his family consisting four members for the financial year 2018-2020.

In this connection, it is further submitted that officer has already submitted his property statement upto the financial year 2016-18 which has been Seen by Hon'ble Mr. Justice R.R.Awasthi, the then Administrative Judge, Sitapur offline in the Misc. file of the officer.

It is again submitted that as per policy/Court's Circular letter, the officer has to submit his property statement for the financial years 2018-2020 (2018-2019 & 2019-2020) in its next financial year i.e. 2020-2021 upto March, 2021. He has submitted movable and immovable property statements of the financial years 2018-2020 (2018-2019 & 2019-2020) vide online letter dated 20.02.2021. As such, there is no delay in submitting the aforesaid property statements from the part of officer.

May, therefore, if approved, property statements for the financial years 2018-2020 (2018-2019 & 2019-2020) of Sri Vishwanath presently Additional District & Sessions Judge, Ambedkar Nagar be laid before Hon'ble Mr. Justice Rajendra Kumar-IV , Administrative Judge, Ambedkar Nagar for His Lordship's kind perusal and orders?
