May kindly see the property statement submitted online dated 09.12.2021 received from Sri Vivek Vikram, Addl. Civil Judge (Sr.Div.)/ACJM., Agra, regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family for the financial year 2017-19 (2017-18 & 2018-19) in the prescribed proforma respectively to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial years 2017-19 (2017-18 & 2018-19) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below.

(1) In the financial year 2017-19 (2017-18 & 2018-19), gross income from salary is Rs.18,24,077/and total deductions/ repayment/ savings/ investment (for both the financial years) against GIS, NPS, Income Tax and Insurance policies, total of which is Rs.8,57,313/-. Thus, a sum of Rs.9,66,764/- was therefore available with him to meet out the household expenditure of his in both the financial years. And the balance of his savings bank account(s) is reduced for Rs.3,76,536/- this financial year from previous year's balance.

It is pertinent to mention here that Sri Ganesh Prasad, Father, Government Servant, Rs.81000 Monthly income.

In this connection, it is submitted that the officer has submitted online his property statement upto the financial year 2015-17, which has already been processed online before Hon'ble Mr. Justice Jayant Banerji, Administrative Judge, Agra on old case-id no.166.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement of the financial years 2017-19 (2017-18 & 2018-19) in its next financial year i.e., 2019-20 upto March 2020. He has submitted movable and immovable property statements of the financial years 2017-19 (2017-18 & 2018-19) firstly vide online dated 9.12.2021. As such, there is delay in submitting the same from the part of the officer for which he has stated that delay caused due to workload and human error. for which officer sincerely apologises for the same.

May, therefore, if approved, property statements of the financial year 2017-19 (2017-18 & 2018-19) of Sri Vivek Vikram, Addl. Civil Judge (Sr.Div.)/ACJM., Agra, be laid before Hon'ble Mr. Justice Jayant Banerji, Administrative Judge, Agra Judgeship for His Lordship's kind perusal and orders?
