May kindly see the property statement submitted online received from Sri Deepak Yadav, Additional District & Sessions Judge, Hardoi, regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family for the financial year 2018-20 (2018-19 & 2019-20) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statements of movable and immovable properties for the financial years 2018-20 (2018-19 & 2019-20) of the officer, concerned, details of income, deductions, savings, investment and expenditure made by him are given below.

In the financial year 2018-20 (2018-19 & 2019-20), his Total income from salary and other sources is Rs. 44,53,074/- (Rs. 36,70,104/- from Pay & arrear of D.A., arrears of interim relief, Leave Encashment and other allowances, Rs. 1329/- F.D. interest, Rs. 2,81,641/- received from Late father's pension a/c as nominee and Rs. 5,00,000/- PPF withdrawal) and total deductions/savings/investments against PRAN, GIS, Income Tax, PPF, Insurances and Sukanya Samridhi Yojna is Rs. 20,89,884/-. Thus a sum of Rs. 23,63,190/- was therefore available with him to meet out the household expenditure of his family consisting four members in both the financial years. The balance of his savings bank account(s) is also reduced for Rs. 4,26,301/- this financial year from previous year's balance.

It is pertinent to mention here that his wife is working as a teacher in Rabindranath Tagore Public school, Lucknow and her annual income is Rs. 2,16,000/- and 2,40,000/- respectively for the both the financial year.

In this connection, it is submitted that the officer has already submitted his property statements offline for the financial years 2016-18 (2016-17 & 2017-18) which has already been seen by Hon'ble Mr. Justice B. Amit Sthalekar, the then Administrative Judge, Varanasi in the misc. file of the officer.

It is further submitted that as per policy/Court's Circular letter, the officer has to submit his property statements for the financial year 2018-20 (2018-19 & 2019-20) in its next financial year i.e., 2020-21 upto 31st March 2021. He has submitted movable and immovable property statements for the financial years 2018-20 (2018-19 & 2019-20) firstly vide his application dated 21.01.2021. As such, there is no delay in submitting the same from the part of the officer.

May therefore, if approved, property statements for the financial years 2018-20 (2018-19 & 2019-20) of Sri Deepak Yadav, Additional District & Sessions Judge, Hardoi, be laid before Hon'ble Mr. Justice Abdul Moin, Administrative Judge, Hardoi for His Lordship's kind perusal and orders?
