In this connection, it is submitted that the officer has already submitted his property statements offline for the financial year 2016-18 which was seen by Hon'ble Mr. Justice S. P. Kesharwani, the then Administrative Judge, Mau in the miscellaneous file of the officer.

It is further submitted that as per policy/Court's Circular letter, the officer has to submit his property statements for the financial year 2018-20 (2018-19 & 2019-20) in its next financial year i.e., 2020-21 upto March 2021. He has submitted movable and immovable property statements for the financial years 2018-20 (2018-19 & 2019-20) vide his online application dated 21.01.2021. As such, there is no delay in submitting the same from the part of the officer.

May, therefore, if approved, property statements for the financial years 2018-20 (2018-19 & 2019-20) of Sri Mukesh Mishra, District & Sessions Judge, Lakhimpur Kheri be laid before Hon'ble Mr. Justice Abdul Moin, Administrative Judge, Lakhimpur Kheri for His Lordship's kind perusal and orders
