May kindly see the property statement submitted online dated 25.01.2021 received from Sri Nitish Kumar Rai, Registrar (Judicial) (Admin.), Hon'ble High Court of Judicature at Allahabad, Lucknow Bench, Lucknow regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family for the financial years 2014-15 & 2015-16 in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial years 2014-15 & 2015-16 of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below.

(1) In the financial years 2014-15 & 2015-16, total income from salary & rental income are Rs.26,13,451/- and total deductions/ repayment/ savings/ investment (for both the financial years) against GIS, NPS, Income Tax, Home Loan, LIC policies and the balance of his savings bank account(s) is enhanced for Rs.49,082/- this financial year from previous year's balance, total of which is Rs.11,52,859/-. Thus, a sum of Rs.14,60,592/- was therefore available with him to meet out the household expenditure of his family consisting four members in both the financial years.

It is pertinent to mention here that his wife earns around Rs.12,000 - Rs.15,000/- monthly approx. from Tuition.

In this connection, it is submitted that the officer has already submitted his property statement upto the financial year 2013-14 online, which had already been seen by Hon'ble the Chief Justice, on case Id no.1971.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement of the financial years 2014-15 & 2015-16 in its next financial year i.e., 2016-17 upto March 2017. He has submitted movable and immovable property statements of the financial years 2014-15 & 2015-16 vide online dated 25.01.2021. As such, there is delay in submitting the same from the part of the officer for which he has stated that "due to rush of work he inadvertently failed to submit his Property Statement in time for the financial year 2014-16. He undertake to be prompt and punctual in future. So it is kindly requested to condone the delay for the submission of property statement. He shall be highly obliged." mentioned in his reply dated 10.03.2021.

Here, it is also submitted that as per resolution dated 12.07.2013 of Hon'ble the Administrative Committee, the matter is likely to be submitted before Hon'ble the Chief Justice, as the officer is presently posted at Hon'ble High Court of Judicature at Allahabad, Lucknow Bench, Lucknow.

May, therefore, if approved, property statements of the financial years 2014-15 & 2015-16 (F.Y. 2014-16) of Sri Nitish Kumar Rai, Registrar (Judicial) (Admin.), Hon'ble High Court of Judicature at Allahabad, Lucknow Bench be laid before Hon'ble The Acting Chief Justice for His Lordship's kind perusal and orders?
