May kindly see the property statement submitted online dated 25.01.2021 received from Sri Nitish Kumar Rai, Registrar (Judicial) (Admin.), High Court of Judicature at Allahabad, Lucknow Bench, Lucknow regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family for the financial years 2016-17 & 2017-18 in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial years 2016-17 & 2017-18 of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below.

(1) In the financial years 2016-17 & 2017-18, total income from salary & rental income are Rs.30,08,074/- and total deductions/ repayment/ savings/ investment (for both the financial years) against GIS, NPS, Income Tax, Home loan, Car loan and LIC policies are Rs.12,21,001/-. Thus, a sum of Rs.17,87,073/- was therefore available with him to meet out the household expenditure of his family consisting four members in both the financial years. And the balance of his savings bank account(s) is also reduced for Rs.98,236/- this financial year from previous year's balance.

It is pertinent to mention here that his wife earns around Rs.12,000/- approx. monthly from Tuition.

In this connection, it is submitted that the officer has already submitted his property statement upto the financial years 2013-14 online which had already been seen by Hon'ble the Chief Justice on e-service Id no.1971 and 2014-15 & 2015-16 has been recently submitted before Hon'ble The Acting Chief Justice for kind perusal and orders with the detailed office note, submitted online on case Id no. 2065.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement of the financial years 2016-17 & 2017-18 in its next financial year i.e., 2018-19 upto March 2019. He has submitted movable and immovable property statements of the financial years 2016-17 & 2017-18 vide online dated 25.01.2021. As such, there is delay in submitting the same from the part of the officer for which he has stated that "due to the rush of work he inadvertently failed to submit the property statement in time. So with deep reverence, kindly requested to condone the delay and accept the property statement submitted by him".

Here, it is also submitted that as per resolution dated 12.07.2013 of Hon'ble the Administrative Committee, the matter is likely to be submitted before Hon'ble the Chief Justice, as the officer is presently posted at High Court of Judicature at Allahabad, Lucknow Bench, Lucknow.
