May kindly see the property statement online received from Sri. Brajendra Mani Tripathi, District & Sessions Judge, Hapur regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family of the financial year 2018-20(2018-19 & 2019-20) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per the statement of movable and immovable properties for the financial years 2018-20(2018-19 & 2019-20) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below:

(1) In the financial years 2018-20(2018-19 & 2019-20), Gross income from salary is Rs.53,58,091/- and total deductions/ repayment/ savings/ investment against GPF, GIS, Income Tax, Home Loan Emi, SBI Loan Emi, PPF, LIC Policy's and the balance of his savings bank account(s) is enhanced by Rs.2,36,582/- this financial year from previous year's balance, total of which is Rs.35,83,301/-. Thus, a sum of Rs.17,74,790/- was available with him to meet out the household expenditure of his family consisting of three members in both of the financial years.

In this connection, it is submitted that the Officer has already submitted his property statements of the 2016-18 offline and same has been approved by the Hon'ble Dr. Justice D.K. Arora, the then, Administrative Judge, Jhansi Judgeship in misc. file of the officer.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial years 2018-20(2018-19 & 2019-20) in its next financial year i.e., 2020-21 upto March 2021. He has submitted movable and immovable property statements of the financial years 2018-20(2018-19 & 2019-20) vide online dated 04.12.2021. As such, there is delay in submitting the same. In this regard officer has stated that " The property statement was submitted on 23.01.2021. Due to spread of COVID-19, the Tribunal was either closed for most of the period or entry of employees were ristricted. officer was posted as P.O. MACT Allahabad where about 8,000 cases were pending and only two Class-III employee and one stenographer were posted in tribunal. Those employees had no experience of court working. Further, father of officer was critically ill and succumb to illnes on 31.08.2020. Due to these reasons, property statement could not be submitted on time."

May, therefore, if approved, property statements for the financial years 2018-20(2018-19 & 2019-20) of Sri. Brajendra Mani Tripathi, District & Sessions Judge, Hapur be laid before Hon'ble Mrs. Justice Saroj Yadav, Administrative Judge, Hapur for Her Lordship's kind perusal and orders?
