May kindly see the property statement submitted online dated 25.01.2021 received from Sri Nitish Kumar Rai, Registrar (Judicial) (Admin.), Hon'ble High Court of Judicature at Allahabad, Lucknow Bench, Lucknow regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family for the financial years 2018-19 & 2019-20 in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial years 2018-19 & 2019-20 of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below.

(1) In the financial years 2018-19 & 2019-20, Gross income from salary is Rs.42,62,496/- and total deductions/ repayment/ savings/ investment (for both the financial years) against GIS, NPS, Income Tax, Home loan, Car loan, LIC policies, PPF a/c and the balance of his savings bank account(s) is enhanced for Rs.33,711/- this financial year from previous year's balance, total of which is Rs.21,18,487/-. Thus, a sum of Rs.21,44,009/- was therefore available with him to meet out the household expenditure of his family consisting four members in both the financial years.

In this connection, it is submitted that the officer has already submitted his property statement upto the financial years 2013-14 online which had already been seen by Hon'ble the Chief Justice, on e-service Id no.1971 and of the financial years 2014-15 & 2015-16 and 2016-17 & 2017-18 has been recently submitted before Hon'ble The Acting Chief Justice for kind perusal and orders with the detailed office notes, submitted online on e-service Id nos.2065 and 2066 respectively.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement of the financial years 2018-19 & 2019-20 in its next financial year i.e., 2020-21 upto March 2021. He has submitted movable and immovable property statements of the financial years 2018-19 & 2019-20 vide online dated 25.01.2021. As such, there is no delay in submitting the same.

Here, it is also submitted that as per resolution dated 12.07.2013 of Hon'ble the Administrative Committee, the matter is likely to be submitted before Hon'ble the Chief Justice, as the officer is presently posted at High Court, Lucknow Bench, Lucknow.

May, therefore, if approved, property statements of the financial years 2018-19 & 2019-20 (F.Y. 2018-20) of Sri Nitish Kumar Rai, Registrar (Judicial) (Admin.), Hon'ble High Court of Judicature at Allahabad, Lucknow Bench, Lucknow be laid before Hon'ble The Acting Chief Justice for His Lordship's kind perusal and orders?
