May kindly see the property statement online received from Smt. Pratiksha Nagar, Special Judge (Essential Commodities Act), Jhansi regarding submission of statement of movable and immovable properties acquired/held by her or any member of her family for the financial years 2018-19 & 2019-20 in the prescribed proforma respectively to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial years 2018-19 & 2019-20 of the officer concerned, details of income, deduction, savings investment and expenditure made by her are given below.

(1) In the financial years 2018-19 & 2019-20, Total income from salary are Rs.43,43,477/- (Income from salary is Rs.40,43,477/- & income from rent is Rs.3,00,000/-) and total deductions/ repayment/ savings/ investment (for both the financial years) against NPS, GIS, Income Tax, Car loan, PPF a/c, FDs and Gold bond are Rs.44,73,360/-, which is more than her income. And the balance of her SB a/cs is also reduced for Rs.787/- in this financial year from previous year's balance.

However, it is also pertinent to mention here that "her husband is also a judicial officer who looks after major household expenses. They have a nuclear family having only one child aged 12 years and do not have any responsibility of their parents" (mentioned in column no.6 of movable proforma) and her husband's average annual income of Rs.20,00,000/- & working as Additional District & Sessions Judge.

In this connection, it is submitted that the officer has already submitted her property statement at the time of joining into judicial service which has already been seen by Hon'ble Mr. Justice Rajan Roy, the then Administrative Judge, Lucknow in the misc file of the officer.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit her property statement for the financial years 2018-19 & 2019-20 in its next financial year i.e., 2020-21 upto March 2021. She has submitted movable and immovable property statements for the financial years 2018-19 & 2019-20 vide online dated 28.01.2021. As such, there is no delay in submitting the same from the part of the officer.

May, therefore, if approved, property statements for the financial year 2018-19 & 2019-20 of Smt. Pratiksha Nagar, Special Judge (Essential Commodities Act), Jhansi be laid before Hon'ble Mr. Justice Neeraj Tiwari, Administrative Judge, Jhansi Judgeship for His Lordship's kind perusal and orders?
