May kindly see the online application received from Smt. Reeta Kaushik, Principal Judge, Family Court, Faizabad regarding submission of statements of movable and immovable properties for the financial years 2018-20 (2018-19 and 2019-20) on proforma to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per statements of movable and immovable properties for the financial years 2018-20 (2018-19 and 2019-20) of the officer concerned, details of income, deductions, savings, investment and expenditure made by her are given below.

In the financial years 2018-20 (2018-19 and 2019-20), her total gross income from salary (including LLM Arrears) and income from interest (On FDR and Savings Acc.) is Rs. 71,43,107/- and total deductions/savings/investments against Income Tax, PPF, GIS, GPF, FDR and the balance of her Savings Bank Accounts is enhanced by Rs. 3,27,835/- this financial year from previous year's balance, total of which is Rs. 26,57,494/-. Thus, a sum of Rs. 44,85,613/- was therefore available with her to meet out the household expenditure consisting of 3 members in the financial years 2018-20 (2018-19 and 2019-20).

It is pertinent to mention here that Shri Bhoo Dev Gautam who is the husband of the officer is posted as Additional District and Sessions Judge, Faizabad with Basic Pay Scale of Rs. 63,070/-.

In this connection it is submitted that the officer has already submitted her property statements upto the financial years 2017-18 which were 'Seen' by Hon'ble Mr. Justice Manoj Kumar Gupta, Administrative Judge, Faizabad Judgeship in the Misc. file of the officer.

The movable and immovable property statements for the financial years 2018-20 (2018-19 and 2019-20) have been submitted by the officer vide her online application dated 26.01.2021 which were due to be submitted upto the end of the financial year 2020-21 i.e. on or before 31.03.2021. As such, there is no delay on the part of the officer in submission of property statement.

May, if approved, the statements of movable and immovable property for the financial years 2018-20 (2018-19 and 2019-20) of Smt. Reeta Kaushik, Principal Judge, Family Court, Faizabad may kindly be placed before Hon'ble Mr. Justice Salil Kumar Rai, Administrative Judge, Faizabad Judgeship for His Lordship's kind perusal and orders.
