

## **Registrar(J)(Budget)**

May kindly see the property statement online received from Sri Sanjay Kumar Singh-I, Registrar (J)(Admin.), High Court, Lucknow Bench, Lucknow regarding submission of statement for movable and immovable properties acquired/held by him or any member of his family of the financial years 2016-18 (2016-17 & 2017-18) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per the statement of movable and immovable properties for the financial years 2016-18 (2016-17 & 2017-18) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below:

In the financial years 2016-18 (2016-17 & 2017-18), his gross income from salary is Rs.24,42,692/- and total deductions/Savings/investments against Savings in Bank account, GPF, GIS, Income Tax, PPF, Repayment of loans and Insurances is Rs.18,92,406/-. The balance of Rs.3,092/- has decreased from his saving bank A/c's against the balance of the previous year. Thus a sum of Rs.5,53,378/- (Rs.5,50,286/- from salary and Rs.3,092/- from saving bank account) was therefore available with him to meet out the household expenditure of his family consisting four members in the financial years 2016-18 (2016-17 & 2017-18).

In this connection, it is submitted that the Officer has already submitted his property statement for the financial years 2010-11 to 2015-16 (offline mode), which had already been seen by Hon'ble the then Acting Chief Justice in the miscellaneous file of the Officer.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial years 2016-18 (2016-17 & 2017-18) in its next financial year i.e., 2018-19 upto March 2019. He has submitted movable and immovable property statements for the financial years 2016-18 (2016-17 & 2017-18) vide dated 29.01.2022. As such, there is delay in submitting the same. In this regard, officer verbatim: **“With Reference to the circular Letter of Honb'le High court 25/Admin (A-4) dated July 13.1.1998. It is required that property statement for year 2017-19 had to be submitted on 1st of January but due to spread of pandemic in year 2020 and rush of work load, inadvertently the same has not been submitted on time for which undersign sincerely seek apology and ensure that in future it will not be repeated”**

May, therefore, if approved, property statements for the financial years 2016-18 (2016-17 & 2017-18) of Sri Sanjay Kumar Singh-I, Registrar (J)(Admin.), High Court, Lucknow Bench, Lucknow be laid before Hon'ble The Chief Justice, High Court, Allahabad for His Lordship's kind perusal and orders?
