May kindly see the online application received from Smt. Shruti Verma, Civil Judge (Senior Division), Kanpur Nagar regarding submission of statements of movable and immovable properties for the financial years 2017-19 (2017-18 and 2018-19) on proforma to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per statements of movable and immovable properties for the financial years 2017-19 (2017-18 and 2018-19) of the officer concerned, details of income, deductions, savings, investment and expenditure made by her are given below.

In the financial years 2017-19 (2017-18 and 2018-19), her total gross income from salary is Rs. 16,67,961/- and total deductions/savings/investments/repayment against Income Tax, PPF, GIS, Car Loan and the balance of her Savings Bank Accounts is enhanced by Rs. 1,26,542/- this financial year from previous year's balance, total of which is Rs. 7,66,510/-. Thus, a sum of Rs. 9,01,451/- was therefore available with her to meet out the household expenditure in the financial years 2017-19 (2017-18 and 2018-19) consisting of 4 members.

It is pertinent to mention here that Shri Praveen Ranjan who is the husband of the officer is in business with annual income of Rs. 6-7 lacs.

In this connection, it is submitted that the officer has already submitted her property statement at the time of joining which has been submitted to Hon'ble Mr. Justice Mahesh Chandra Tripathi, Administrative Judge, Kanpur Nagar processed on e-service id no. 2090.

The movable and immovable property statements for the financial years 2017-19 (2017-18 and 2018-19) have been submitted by the officer vide her online application dated 29.01.2021 which were due to be submitted upto the end of the financial year 2019-20 i.e. on or before 31.03.2020. As such, there is delay in submitting the aforesaid statement on part of the officer for which she has not given any reason.

May, if approved, the statements of movable and immovable property for the financial years 2017-19 (2017-18 and 2018-19) of Smt. Shruti Verma, Civil Judge (Senior Division), Kanpur Nagar may kindly be placed before Hon'ble Mr. Justice Mahesh Chandra Tripathi, Administrative Judge, Kanpur Nagar Judgship for His Lordship's kind perusal and orders.
