May kindly see the property statement submitted online received on 22.02.2021 from Sri Ravindra Kumar Dwivedi, Registrar (Judicial) (Criminal), Hon'ble High Court of Judicature at Allahabad regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family for the financial years 2018-19 & 2019-20 (F.Y. 2018-2020) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and acceptance by the Hon'ble Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial years 2018-19 & 2019-20 (F.Y. 2018-2020) of the officer concerned, details of income, deductions, savings, investments and expenditure made by him are given below.

(1) In the financial year 2018-19 & 2019-20 (F.Y. 2018-2020), total income is Rs.41,41,602/- (including arrears of interim 7th pay commission) and total deductions/ repayments/ savings/ investments against GIS, Income Tax, NPS, LIC policies, PPF A/c, Sukanya Samridhi Yojna, Mutual funds, Loans and, the balance of his savings bank account(s) is enhanced for Rs.3,29,818/- this financial year from previous year's balance, total of which comes to Rs.22,87,852/-. Thus, a sum of Rs.18,53,750/- was therefore available with him to meet out the household expenditure of his family consisting five members in both the financial years.

It is pertinent to mention here that his wife earns annual income of Rs.70,600/- as a Lawyer in the financial year 2018-19 and received rental income of Rs.72,000/- (being co-owner of flat in Lucknow) in the financial year 2019-20.

In this connection it is submitted that the officer has already submitted his property statement upto the financial year 2017-18, which had already been seen by Hon'ble the Chief Justice, in the misc. file of the officer.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial years 2018-19 & 2019-20 in its next financial year i.e., 2020-21 upto March 2021. He has submitted movable and immovable property statements of the financial year 2018-19 & 2019-20 (F.Y. 2018-2020) through online service received on 22.02.2021. As such, there is no delay in submitting the property statement from the part of the officer.

Here it is also submitted that as per resolution dated 12.07.2013 of Hon'ble The Administrative Committee, the matter is likely to be submitted before Hon'ble the Chief Justice, as the officer is presently posted at Hon'ble High Court of Judicature at Allahabad.

May, therefore, if approved, property statements for the financial year 2018-19 & 2019-20 (F.Y. 2018-2020) of Sri Ravindra Kumar Dwivedi, Registrar(Judicial)(Criminal), Hon'ble High Court of Judicature at Allahabad be laid before Hon'ble The Acting Chief Justice for His Lordship's kind perusal and orders?
