**May** kindly see the online application received from Sri Manoj Kumar Singh-III, the then Additional District and Sessions Judge, Sultanpur presently posted as Special Secretary and Additional L.R.(Legislative), Government of UP, Lucknow regarding submission of statements of movable and immovable properties for the financial years 2018-20( 2018-19 and 2019-20)on proper proforma to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statements of movable and immovable properties for the financial years 2018-20(2018-19 and 2019-20) of the Officer concerned, details of income, deductions, savings, investment and expenditure made by him are given below.

1. In the financial years 2018-20(2018-19 and 2019-20) his gross income from salary and other sources is Rs.43,57,367/- (Rs. 42,91,367/- from salary and Rs. 66,000/- from Agriculture) and total deductions/Savings/investments against GPF, GIS, income tax, PPF, SD, LIC & Housing loan is Rs. 20,51,011/- (including enhancement of balance of Rs.6,66,889/- in his saving bank A/c against the balance of the previous year). Thus a sum of Rs.23,06,356/- was therefore available with him to meet out the household expenditure of his family consisting of four members in the financial year 2018-20(2018-19 and 2019-20).

In this connection it is submitted that the officer has already submitted his property statements upto the financial year 2017-18 which has already been seen by Hon'ble Mr. Justice M.N.Bhandari, the then Administrative Judge, Firozabad with the direction that the officer concerned be directed not to cause any delay in future while submitting property statement in the Misc. file of the officer.

The movable and immovable property statement for the financial years 2018-20(2018-19 and 2019-20) have been submitted by the Officer online dated 25.02.2021 which were due to be submitted in the next financial year i.e. 2020-21 upto March 2021. As such, there is no delay in submitting the property statements from the part of the officer.

May, if approved, the statements of movable and immovable property for the financial years 2018-20(2018-19 and 2019-20) of Sri Manoj Kumar Singh-III, presently posted as Special Secretary and Additional L.R.(Legislative), Government of UP, Lucknow kindly be laid before Hon'ble Mr. Justice Mahesh Chandra Tripathi, Administrative Judge, Lucknow Judgeship for His Lordship's kind perusal and orders?
