May kindly see the property statement online received from Sri. Jitendra Kumar Sinha, District & Sessions Judge, Ghaziabad regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family of the financial years 2018-20 (2018-19 & 2019-20) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per the statement of movable and immovable properties for the financial years 2018-20 (2018-19 & 2019-20) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below:

(1) In the financial years 2018-20 (2018-19 & 2019-20), Gross income from salary is Rs.54,54,008/- and total deductions/ repayment/ savings/ investment against NPS, GIS, Income Tax, HRR, GVR, PPF, LIC policy's, SBI Life Policy, Home Loan EMI and the balance of his savings bank account(s) is enhanced by Rs.6,69,529/- this financial year from previous year's balance, total of which is Rs.29,30,340/-. Thus, a sum of Rs.25,23,668/- was available with him to meet out the household expenditure of his family consisting of five members in both of the financial years.

It is pertinent to mention here that his Father is retired District Judge having Annual Income Rs.9,00,000/- approx.

In this connection, it is submitted that the Officer has already submitted his property statements of the financial year 2017-18 offline, which had already been seen by the Hon'ble Mr. Justice Pankaj Naqvi, the then, Administrative Judge, Bareilly in the Misc. file of the officer. It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial year 2018-20 (2018-19 & 2019-20) in its next financial year i.e., 2020-21 upto March 2021. He has submitted movable and immovable property statements of the financial years 2018-20 (2018-19 & 2019-20) vide online dated 09.02.2021. As such, there is no delay in submitting the same.

May, therefore, if approved, property statements for the financial year 2018-20 (2018-19 & 2019-20) of Sri. Jitendra Kumar Sinha, District & Sessions Judge, Ghaziabad be laid before Hon'ble Mr. Justice Attau Rahman Masoodi, Administrative Judge, Ghaziabad for His Lordship's kind perusal and orders?
