

## **Joint Registrar(J)(Budget)**

May kindly see the property statement online received from Sri Mahendra Prasad Chaudhary, Principal Judge, Family Court, Hardoi regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family of the financial years 2018-19 & 2019-20 in the prescribed proforma respectively to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial years 2018-19 & 2019-20 of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below-

(1) In the financial years 2018-19 & 2019-20, Total income is Rs.84,72,127/- (Gross salary is Rs.53,37,931/-, interests on FD & Bank a/cs of Rs.4,13,961/-, matured amount of FD of Rs.24,07,774/-, matured amount of policy of Rs.2,74,501/- and IT refund of Rs.37,960/-) and total deductions/repayment/savings/ investment against GPF, GIS, Income Tax, loan, MIS, Term deposit, PPF a/cs and the balance of his savings bank account(s) is enhanced for Rs.6,23,128/- this financial year from previous year's balance, total of which is Rs.34,98,894/-. Thus, a sum of Rs.49,73,233/- was therefore available with him to meet out the household expenditure of his family consisting four members for both the financial years 2018-19 & 2019-20.

In this connection, it is submitted that officer has already submitted his property statement upto the financial year 2017-18 which had already been seen by Hon'ble Mr. Justice Rajan Roy, Administrative Judge, Lucknow in the misc. file of the officer.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial years 2018-19 & 2019-20 in its next financial year i.e., 2020-21 upto March 2021. He has submitted movable and immovable property statements of the financial years 2018-19 & 2019-20 vide online dated 10.02.2021. As such, there is no delay in submitting the same from the part of the officer.

May, therefore, if approved, property statements for the financial year 2018-19 & 2019-20 of Sri Mahendra Prasad Chaudhary, Principal Judge, Family Court, Hardoi be laid before Hon'ble Mr. Justice Rajnish Kumar, Administrative Judge, Hardoi for His Lordship's kind perusal and orders?
