May kindly see the property statement online received from Sri Amit Veer Singh, the then Special Judge (E.C Act), Rampur, presently posted as Additional District & Sessions Judge, Rampur regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family of the financial years 2016-18 in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per the statement of movable and immovable properties for the financial years 2016-18 of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below:

(1) In the financial years 2016-18, Total income is Rs.36,28,244/- (Gross Income from salary is Rs. 30,18,503/-, Cashback from LIC is Rs. 75,000/- , NSC Matured for Rs. 3,76,135/- and FD Matured for Rs. 1,58,606/-) and total deductions/ repayment/ savings/ investment against LIC, RLI, GIS, PLI, CPF, Income Tax, PPF, Mutual Fund's, SIP's , total of which is Rs.25,52,966/-. Thus, a sum of Rs.10,75,278/- was available with him to meet out the household expenditure of his family consisting of four members in both of the financial years and the balance of his savings bank account(s) is Decreased by Rs.7,35,856/- this financial year from previous year's balance.

In this connection, it is submitted that the Officer has already submitted his property statements upto the financial year 2014-16 online and same has been moved before the Hon'ble Mr. Justice Alok Mathur, Administrative Judge, Rampur Judgeship.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial years 2016-18 in its next financial year i.e., 2018-19 upto March 2019. He has submitted movable and immovable property statements of the financial years 2016-18 vide online dated 10.02.2021. As such, there is delay in submitting the same. In this regard officer has not given any reason.

May, therefore, if approved, property statements for the financial years 2016-18 of Sri Amit Veer Singh, the then Special Judge (E.C Act), Rampur, presently posted as Additional District & Sessions Judge, Rampur be laid before Hon'ble Mr. Justice Alok Mathur, Administrative Judge, Rampur for His Lordship's kind perusal and orders?
