In this connection, it is submitted that the Officer has already submitted his property statements upto the financial year 2016-18 online and same has been moved before the Hon'ble Mr. Justice Alok Mathur, Administrative Judge, Rampur Judgeship.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial years 2018-20 in its next financial year i.e., 2020-21 upto March 2021. He has submitted movable and immovable property statements of the financial years 2018-20 vide online dated 10.02.2021. As such, there is no delay in submitting the same.
