May kindly see the property statements submitted online received from Smt. Anjana, Additional District & Sessions Judge (POCSO), Jhansi regarding submission of statement of movable and immovable properties acquired/held by her or any member of her family for the financial years 2018-19 & 2019-20 in the prescribed proforma respectively to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial years 2018-19 & 2019-20 of the officer concerned, details of income, deduction, savings investment and expenditure made by her are given below.

(1) In the financial years 2018-19 & 2019-20, Total Gross income from salary are Rs.55,50,333/- and total deductions/ repayment/ savings/ investment (for both the financial years) against GIS, Income Tax, GPF, PPF, Home loan, LIC policy and the balance of her savings bank account(s) is enhanced for Rs.43,082/- this financial year from previous year's balance, total of which is Rs.25,00,039/-. Thus, a sum of Rs.30,50,294/- was therefore available with her to meet out the household expenditure of her family consisting four members in both the financial years.

It is pertinent to mention here that her husband is Advocate having annual income of Rs.5,50,000/- & Rs.6,00,000/- in the financial years 2018-19 & 2019-20 respectively.

In this connection, it is submitted that the officer has already submitted her property statements upto the financial years 2015-16 which has already been seen by Hon'ble Ms. Justice Naheed Ara Moonis, the then Administrative Judge, Etawah and property statement of the financial years 2016-17 & 2017-18 has been processed on statement ID-2136, for kind perusal & orders.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit her property statement of the financial years 2018-19 & 2019-20 in its next financial year i.e., 2020-21 upto March 2021. She has submitted movable and immovable property statements of the financial years 2018-19 & 2019-20 vide online dated 12.03.2021. As such, there is no delay in submitting the same.

May, therefore, if approved, property statements of the financial year 2018-19 & 2019-20 of Smt. Anjana, Additional District & Sessions Judge (POCSO), Jhansi be laid before Hon'ble Mr. Justice Neeraj Tiwari, Administrative Judge, Jhansi Judgeship for His Lordship's kind perusal and orders?
