May kindly see the property statement online received from Sri Dinesh Kumar Chaurasia, Additional District & Sessions Judge, Mau regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family of the financial years 2016-2018 (2016-2017 & 2017-2018) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial years 2016-2018 (2016-2017 & 2017-2018) of the officer concerned, details of income, deduction, savings, investment and expenditure made by him are given below:

(1) In the financial years 2016-2018, total income is Rs. 26,02,368/- (Income from salary) and total deduction/ repayment/ savings/ investment/ against N.P.S., G.I.S., P.P.F. (approx.), Income Tax, Sukanya Samriddhi Yagna, repayment of Home loan, Market plus scheme are Rs. 18,73,156/-. Thus, a sum of Rs. 7,29,212/- was available with him to meet out the household expenditure of his family consisting six members for the financial year 2016-2018. And the balance of his savings bank accounts is decreased for 23,674/- this financial year from previous year's balance.

It is pertinent to mention here that his father is pensioner (retired from the post of bank manager) having annual income of Rs. 6,28,162/-.

In this connection, it is further submitted that officer has already submitted his property statement for the period of 2014-16 which had already been seen by Hon'ble Mr. Justice Arvind Kumar Tripathi, the then Administrative Judge, Moradabad in the miscellaneous file of the officer.

It is again submitted that as per policy/Court's Circular letter, the officer has to submit his property statement for the financial years 2016-2018 (2016-2017 & 2017-2018) in its next financial year i.e. 2018-2019 upto March, 2019. He has submitted movable and immovable property statements of the financial years 2016-2018 (2016-2017 & 2017-2018) vide online letter dated 19.02.2021. As such, there is delay in submitting the aforesaid property statements from the part of officer for which he has apologised and stated that in future he shall be more vigilant in sending property statement timely.

May, therefore, if approved, property statements for the financial years 2016-2018 (2016-2017 & 2017-2018) of Sri Dinesh Kumar Chaurasia, Additional District & Sessions Judge, Mau be laid before Hon'ble Mr. Justice Ali Zamin, Administrative Judge, Mau for His Lordship's kind perusal and orders?
