May kindly see the property statement received online from Sri Vimlesh Saroj, Civil Judge (Senior Div.), Bareilly regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family of the financial year 2018-2020 (2018-19 & 2019-20) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per the statement of movable and immovable properties for the financial year 2018-2020 (2018-19 & 2019-20) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below:

In the financial year 2018-2020 (2018-19 & 2019-20), the Gross income is Rs.23,31,839/- and total deductions/savings/investment against GIS, PPF, NPS, Car and Personal Loan repayments, Mutual Fund and Income Tax is Rs.10,44,576/- and the balance of his savings bank account(s) is also decreased by Rs.6,08,017/- in this financial year from previous year's balance. Thus, a sum of Rs.18,95,280/- (Rs.12,87,263/- from Salary and Rs.6,08,017/- from SB account) was therefore available with him to meet out the household expenditure of his family consisting three members of the financial year 2018-2020 (2018-19 & 2019-20).

It is pertinent to mention here that his father having income approx. Rs.20,000/- monthly in both financial years.

In this connection, it is submitted that the Officer has already submitted his property statement for the financial year 2016-2018 (2016-17 & 2017-18) online against Case Id : P00004632020 (Old Case Id : 1182) and the same has been processed before Hon'ble Mr. Justice Ajit Kumar, Administrative Judge, Bareilly Judgeship for His Lordship's kind perusal and orders.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial year 2018-2020 (2018-19 & 2019-20) in its next financial year i.e., 2020-21 upto March 2021. He has firstly submitted movable and immovable property statements of the financial year 2018-2020 (2018-19 & 2019-20) vide online dated 22.02.2021. As such, there is no delay in submitting the same.

May, therefore, if approved, property statements for the financial year 2018-2020 (2018-19 & 2019-20) of Sri Vimlesh Saroj, Civil Judge (Senior Div.), Bareilly, be laid before Hon'ble Mr. Justice Ajit Kumar, Administrative Judge, Bareilly Judgeship for His Lordship's kind perusal and orders?
