May kindly see the property statement online received from Sri. Harshvardhan, Additional District Judge (POCSO), Ghaziabad regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family of the financial years 2018-20 (2018-19 & 2019-20) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per the statement of movable and immovable properties for the financial years 2018-20 (2018-19 & 2019-20) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below:

(1). In the financial year 2018-20 (2018-19 & 2019-20), Gross income from salary and other source's Rs. 62,12,628/- and total deductions/savings/ investment against GPF, GIS, Income Tax, PPF, insurance policies, Mutual fund, Home loan EMI, NSC, is Rs.26,79,597 . Thus a sum of Rs. 35,33,031/- was therefore available with him to meet out the household expenditure of his family consisting of four members in the financial year 2018-20 (2018-19 & 2019-20) and the balance of his savings account is also decreased for Rs.61,039 /- this financial year from previous year balance.

In this connection, it is submitted that the Officer has already submitted his property statement of the financial year 2016-18(2016-17 & 2017-18) offline seen by Hon'ble Mr. Justice Attau Rahman Masoodi, the then Administrative Judge, Farrukhabad in the Misc. file of the officer.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial years 2018-20 (2018-19 & 2019-20) in its next financial year i.e., 2020-21 upto March 2021. He has submitted movable and immovable property statements of the financial year 2018-20 (2018-19 & 2019-20) vide online dated 16.03.2021. As such, there is no delay in submitting the property statements from the part of the officer.

May, therefore, if approved, property statements for the financial years 2018-20 (2018-19 & 2019-20) of Sri. Harshvardhan, Additional District Judge (POCSO), Ghaziabad be laid before Hon'ble Mr. Justice Saumitra Dayal Singh, Administrative Judge, Ghaziabad for His Lordship's kind perusal and orders?
