May kindly see the property statement online received from Sri. Zaigam Uddin, Principal Judge, Family Court, Jalaun at Orai regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family of the financial years 2018-20(2018-19 & 2019-20) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per the statement of movable and immovable properties for the financial years 2018-20(2018-19 & 2019-20) of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below:

(1) In the financial years 2018-20(2018-19 & 2019-20), Total income is Rs.48,77,331/- (Gross income from salary is Rs.44,52,907/-, Petrol Allowence is Rs.78,332/-, Training Allowence is Rs.4,188/-, Bank interest is Rs.2,70,396 & Transfer Allowence is Rs.71,508/-) and total deductions/ repayment/ savings/ investment against GPF, GIS, Income Tax, PPF, LIC Policy's and the balance of his savings bank account(s) is enhanced by Rs.11,61,717/- this financial year from previous year's balance, total of which is Rs.29,45,198/-. Thus, a sum of Rs.19,32,133/- was available with him to meet out the household expenditure of his family consisting of four members in both of the financial years.

In this connection, it is submitted that the Officer has already submitted his property statements of the 2016-18 offline and same has been approved by the Hon'ble Mr. Justice V.K Birla, the then, Administrative Judge, Rae Bareli Judgeship in Misc. file of the Officer.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial years 2018-20(2018-19 & 2019-20) in its next financial year i.e., 2020-21 upto March 2021. He has submitted movable and immovable property statements of the financial years 2018-20(2018-19 & 2019-20) vide online dated 07.12.2021. As such, there is delay in submitting the same. In this regard Officer has stated that " Hon'ble Sir, This property statement of the years 2018-2020 was to be sent in the third financial year i.e. by 31-03-2021. In the year 2021 I suffered with Covid 19, thereafter my wife, my both sons also infected. Besides it my real sister Najmunnisa, my brother-in-law Aqeel Ahmad, uncle Mohd.Jaleel, aunt Khadija, nephew Tabish and niece Goldi @ Hunaira Khanam, all died of Corona disease. My Distt. Judge, also suffered with the above pandemic, being senior most A.D.J. I had to perform all administrative work of this judgeship. In spite all the above reasons I apologize for being late to send this property statement."

May, therefore, if approved, property statements for the financial years 2018-20(2018-19 & 2019-20) of Sri. Zaigam Uddin, Principal Judge, Family Court, Jalaun at Orai be laid before Hon'ble Mr. Justice Dinesh Pathak, Administrative Judge, Jalaun at Orai for His Lordship's kind perusal and orders?
