May kindly see the property statements online received from Sri Rajesh Bhardwaj, Additional District & Sessions Judge, Aligarh regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family for the financial year 2018-19 & 2019-20 in the prescribed proforma respectively to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial years 2018-19 & 2019-20 of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below.

(1) In the financial year 2018-19 & 2019-20, Total Income is Rs.55,87,179/- (Gross salary is Rs.40,65,537/-, SB a/c interest of Rs.12,874/-, PPF withdrawal of Rs.5,49,111/- and policy reimbursement of Rs.9,59,657/-) and total deductions/ repayment/ savings/ investment (for both the financial years) against LIP, GPF, GIS, Insurance policies, Home loan, Income Tax, PPF a/c and the balance of his savings bank account(s) is enhanced for Rs.3,07,250/- this financial year from previous year's balance, total of which is Rs.31,52,942/-. Thus, a sum of Rs.24,34,237/- was therefore available with him to meet out the household expenditure of his family consisting three members in both the financial years.

It is pertinent to mention here that he has now divorced his wife, Court's order is at annexure-I (mentioned in column no. 2 of movable proforma and uploaded in attachment dated 24.03.2021).

In this connection, it is submitted that the officer has already submitted his property statement upto the financial year 2013-14 which had already been seen by Hon'ble Mr. Justice Abhinava Upadhyaya, the then Administrative Judge, Muzaffarnagar in the misc. file of the officer. And property statements of the financial years 2014-16 and 2016-18 have been processed on Statement ID nos. 879 and 889 respectively.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial year 2018-19 & 2019-20 in its next financial year i.e., 2020-21 upto March 2021. He has submitted movable and immovable property statements for the financial years 2018-20 vide online dated 25.03.2021. As such there is no delay in submitting the property statement of the aforesaid financial year.

May, therefore, if approved, property statements for the financial year 2018-19 & 2019-20 of Sri Rajesh Bhardwaj, Additional District & Sessions Judge, Aligarh be laid before Hon'ble Mr. Justice Ashwani Kumar Mishra, Administrative Judge, Aligarh Judgeship for His Lordship's kind perusal and orders?
