May kindly see the property statement online received from Sri Ravish Kumar Attri, Additional District Judge (Posco), Azamgarh regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family of the financial years 2014-2016 (2014-2015 & 2015-2016) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial years 2014-2016 (2014-2015 & 2015-2016) of the officer concerned, details of income, deduction, savings, investment and expenditure made by him are given below:

(1) In the financial years 2014-2016, total income is Rs. 20,96,671/- (Income from salary) and total deduction/ repayment/ savings/ investment/ against C.P.F., G.I.S., Income Tax, L.I.C., P.P.F. (approx.), are Rs. 5,98,091/- (including enhancement of Rs.1,22,904/- in his S.B. A/cs against the balance of the previous year). Thus, a sum of Rs. 14,98,580/- was available with him to meet out the household expenditure of his family consisting four members for the financial year 2014-2016.

It is pertinent to mention here that his wife Smt. Parul Attri is Civil Judge (Senior Division) having annual income of Rs. 1,52,946/-.

In this connection, it is further submitted that officer has already submitted his property statement for the period of 2006-07, 2007-08, 2008-09, 2009-10, 2010-11, 2011-12, 2012-13 and 2013-14 which had already been seen by Hon'ble Mr. Justice Dilip Gupta, the then Administrative Judge, Allahabad on the miscellaneous file of the officer.

It is again submitted that as per policy/Court's Circular letter, the officer has to submit his property statement for the financial years 2014-2016 (2014-2015 & 2015-2016) in its next financial year i.e. 2016-2017 upto March, 2017. He has submitted movable and immovable property statements of the financial years 2014-2016 (2014-2015 & 2015-2016) vide online letter dated 06.03.2021. As such, there is delay in submitting the aforesaid property statements from the part of officer for which he has submitted that due to misplace of previous year statement in annual transfer 2015, delay was caused in submitting the statement.

May, therefore, if approved, property statements for the financial years 2014-2016 (2014-2015 & 2015-2016) of Sri Ravish Kumar Attri, Additional District Judge (Posco), Azamgarh be laid before Hon'ble Mr. Justice Rajan Roy, Administrative Judge, Azamgarh for His Lordship's kind perusal and orders?
