May kindly see the property statement submitted online received from Sri Khaliquzzama, Special Judge (SC/ST, Prevention of Atrocities Act), Sonbhadra regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family for the financial years 2018-19 & 2019-20 in the prescribed proforma respectively to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial years 2018-19 & 2019-20 of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below.

(1) In the financial years 2018-19 & 2019-20, Total income is Rs.44,42,807/- [Gross income from salary & arrears (including leave encashment of Rs.2,90,733/-, interim relief of Padmanabhan Committee of Rs.4,38,891, arrear of D.A. Of Rs.29,216/- and SB interests of Rs.30,719/-)] and total deductions/ repayment/ savings/ investment (for both the financial years) against GIS, GPF, Income Tax, Insurance policies, PPF, loan and the balance of his savings bank account(s) is enhanced for Rs.1,52,441/- this financial year from previous year's balance, total of which is Rs.28,55,412/-. Thus, a sum of Rs.15,87,395/- was therefore available with him to meet out the household expenditure of his family consisting five members in both the financial years.

It is also to mention here that his wife, who was earning member, divorced on 16.02.2020.

In this connection, it is submitted that the officer has already submitted his property statement upto the financial year 2017-18 which had already been seen by Hon'ble Mr. Justice Jaspreet Singh, the then Administrative Judge, Banda in the misc. file of the officer.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial years 2018-19 & 2019-20 in its next financial year i.e., 2020-21 upto March 2021. He has submitted movable and immovable property statements of the financial year 2018-19 & 2019-20 vide online dated 19.03.2021. As such, there is no delay in submitting the same.

May, therefore, if approved, property statements for the financial years 2018-19 & 2019-20 of Sri Khaliquzzama, Special Judge (SC/ST, Prevention of Atrocities Act), Sonbhadra be laid before Hon'ble Mr. Justice Gautam Chowdhary, Administrative Judge, Sonbhadra Judgeship for His Lordship's kind perusal and orders?
