May kindly see the property statement submitted online received from Smt. Parul Attri, presently posted as Additional Principal Judge, Family Court, Azamgarh regarding submission of statement of movable and immovable properties acquired/held by her or any member of her family for the financial year 2014-16 (2014-15 & 2015-2016) in the prescribed proforma respectively to this Hon'ble Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statements of movable and immovable properties for the financial years 2014-16 (2014-15 & 2015-2016) of the officer, concerned, details of income, deductions, savings, investment and expenditure made by her are given below.

In the financial year 2014-16 (2014-15 & 2015-2016), her Total income from salary is Rs. 25,61,084/total deductions/savings/investments against GIS, CPF, Income Tax, PPF, LIC and NSC Rs. 9,25,959/(including enhancement of Rs. 1,24,161/- in his S.B. A/cs against the balance of the previous year). Thus a sum of Rs. 16,35,125/- was therefore available with her to meet out the household expenditure of her family consisting of four members in both the financial years. It is to mention here that the Officer has written GIS two times in the statement which appears to be wrongly mentioned by the Officer and it should be CPF instead of GIS.

It is also pertinent to mention here that her husband Ravish Kumar Attri is also Civil Judge (S.D) in this financial year and his annual income is Rs. 10,80,939/-.

In this connection, it is submitted that the officer has already submitted her property statements offline for the financial year 2013-14 and seen by Hon'ble Mr. Justice Dilip Gupta, the then Administrative Judge, Allahabad with the direction that the property statements have been perused. The Officer may asked to ensure that in future the property statements are submitted in time.

It is further submitted that as per policy/Court's Circular letter, the officer has to submit her property statements for the financial year 2014-16 (2014-15 & 2015-2016) in its next financial year i.e., 2016-17 upto March 2017. She has submitted movable and immovable property statements for the financial years 2014-16 (2014-15 & 2015-2016) firstly vide her application dated 26.07.2021. As such, there is delay in submitting the same from the part of the officer and she has submitted that delayed caused in submitting statement due to misplace of previous statements in annual transfer-2015.

May, therefore, if approved, property statements for the financial years 2014-16 (2014-15 & 2015-2016) of Smt. Parul Attri, presently posted as Additional Principal Judge, Family Court, Azamgarh, be laid before Hon'ble Mr. Justice Rajan Roy, Administrative Judge, Azamgarh for His Lordship's kind perusal and orders?
