May kindly see the online application received from Shri Arvind Kumar Yadav-II, Additional District & Sessions Judge, Bareilly regarding submission of statements of movable and immovable properties for the financial years 2012-14 (2012-13 and 2013-14) on proforma to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per statements of movable and immovable properties for the financial years 2012-14 (2012-13 and 2013-14) of the officer concerned, details of income, deductions, savings, investment and expenditure made by him are given below.

**In the financial years 2012-14 (2012-13 and 2013-14)**, his total gross income from salary is Rs. 17,26,284/- (which includes salary, allowances & arrears and LIC policy maturity amount) and total deductions/savings/investments against Income Tax, PPF, GPF, GIS, insurance policies and the balance of his Savings Bank Accounts is reduced by Rs. 1,49,423/- this financial year from previous year's balance, total of which is Rs. 5,38,338/-. Thus, a sum of Rs. 11,87,946/- was therefore available with him to meet out the household expenditure in the financial years 2012-14 (2012-13 and 2013-14).

It is pertinent to mention here that Smt. Usha Yadav who is the wife of the officer is enrolled as an advocate in Bar Council of U.P and practising as legal adviser, her income is Rs. 25000 in the financial year 2012-13 and Rs. 100,000 in the financial year 2013-14. Smt. Vidyavati Devi who is the mother of the officer is a pensioner (retired teacher) with monthly pension of Rs. 14,500.

In this connection it is submitted that the officer has already submitted his property statements for the financial years 2010-12 which has been seen by Hon'ble Mr. Justice Dilip Gupta, the then Administrative Judge, Gorakhpur in the Misc. file of the officer.

The movable and immovable property statements for the financial years 2012-14 (2012-13 and 2013-14) have been submitted by the officer vide his online application dated 27.10.2021 duly forwarded by the District Judge, Firozabad on 01.11.2021 which were due to be submitted upto the end of the financial year 2014-15 i.e. on or before 31.03.2015. As such, there is delay in submitting the aforesaid statement on part of the officer for which he has not given any reason.

May, if approved, the statements of movable and immovable property for the financial years 2012-14 (2012-13 and 2013-14) of Shri Arvind Kumar Yadav-II, Additional District & Sessions Judge, Bareilly may kindly be placed before Hon'ble Mr. Justice Ajit Kumar, Administrative Judge, Bareilly Judgeship for His Lordship's kind perusal and orders.
