

## **Registrar (J) (Budget)**

May kindly see the online application received from Shri Arvind Kumar Yadav-II, Additional District & Sessions Judge, Bareilly regarding submission of statements of movable and immovable properties for the financial years 2016-18 (2016-17 and 2017-18) on proforma to this Hon'ble Court for kind perusal and information as required by the Hon'ble Court.

In this connection, it is submitted that as per statements of movable and immovable properties for the financial years 2016-18 (2016-17 and 2017-18) of the officer concerned, details of income, deductions, savings, investment and expenditure made by him are given below.

**In the financial years 2016-18 (2016-17 and 2017-18)**, his total gross income from salary is Rs. 26,28,904/- (gross income Rs. 25,28,904/- agricultural income Rs. 100,000/-) and total deductions/savings/investments against Income Tax, PPF, GPF, GIS, insurance policies, loan and the balance of his Savings Bank Accounts is reduced by Rs. 6,64,958/- this financial year from previous year's balance, total of which is Rs. 13,36,860/-. Thus, a sum of Rs. 12,92,044/- was therefore available with him to meet out the household expenditure in the financial years 2016-18 (2016-17 and 2017-18).

It is pertinent to mention here that Smt. Usha Yadav who is the wife of the officer is enrolled as an advocate in Bar Council of U.P and practising as legal adviser, her income is Rs. 200,000/- in the financial year 2016-17 and Rs. 200,000 in the financial year 2017-18. Smt. Vidyavati Devi who is the mother of the officer is a pensioner (retired teacher) with monthly pension of Rs. 14,500.

In this connection it is submitted that the officer has already submitted his property statements for the financial years 2014-16 which has been submitted to Hon'ble Mr. Justice Ajit Kumar, Administrative Judge, Bareilly Judgeship processed on e-service id no. 2193.

The movable and immovable property statements for the financial years 2016-18 (2016-17 and 2017-18) have been submitted by the officer vide his online application dated 27.10.2021 which were due to be submitted upto the end of the financial year 2018-19 i.e. on or before 31.03.2019. As such, there is delay in submitting the aforesaid statement on part of the officer for which he has not given any reason.

May, if approved, the statements of movable and immovable property for the financial years 2016-18 (2016-17 and 2017-18) of Shri Arvind Kumar Yadav-II, Additional District & Sessions Judge, Bareilly may kindly be placed before Hon'ble Mr. Justice Ajit Kumar, Administrative Judge, Bareilly Judgeship for His Lordship's kind perusal and orders?
