May kindly see the property statement submitted online received from Sri Arvind Kumar Yadav-II, Additional District & Sessions Judge, Bareilly regarding submission of statement of movable and immovable properties acquired/held by him or any member of his family for the financial years 2018-19 & 2019-20 in the prescribed proforma to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that as per statement of movable and immovable properties for the financial years financial years 2018-19 & 2019-20 of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below-

(1) In the financial years 2018-19 & 2019-20, Total income is Rs.40,01,807/- (Gross income of Rs.36,07,114/-, income from agriculture cash & crops of Rs.2,00,000/- and maturity of NSC of Rs.1,94,693/-) and total deductions/ repayment/ savings/ investment (for both the financial years) against GPF, GIS, Income Tax, Ioan, LIC policies, PPF and the balance of his savings accounts is enhanced for Rs.7,04,868/- this financial year from previous year's balance, total of which is Rs.20,35,802/-. Thus, a sum of Rs.19,66,005/- was therefore available with him to meet out the household expenditure of his family consisting five members in both the financial years.

It is pertinent to mention here that his wife enrolled as Advocate of Bar Council of U.P. and practice as Legal Adviser having annual income of Rs.2,50,000/- & 4,50,000/- in the financial years 2018-19 & 2019-20 respectively.

In this connection, it is submitted that the officer has already submitted his property statement upto the financial year 2017-18 which had already been processed and submitted before Hon'ble the Administrative Judge on case-ID 2194.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the financial years 2018-19 & 2019-20 in its next financial year i.e., 2020-21 upto March 2021. He has submitted movable and immovable property statements of the financial years 2018-19 & 2019-20 firstly vide online dated 03.03.2021. As such, there is no delay in submitting the same.

May, therefore, if approved, property statements for the financial years 2018-19 & 2019-20 of Sri Arvind Kumar Yadav-II, Additional District & Sessions Judge, Bareilly be laid before Hon'ble Mr. Justice Vivek Chaudhary, Administrative Judge, Bareilly Judgeship for His Lordship's kind perusal and order?
